#### **4. Arrangements**

The Department of Health, Ministry of Public Health will be providing 2-way air ticket (economy class), accommodation, meals and local transportation of international participants, speaker and ASEAN Secretariat. All flight and room arrangement shall only be made after participants have submitted their completed registration forms.

For air ticket (economy class), please buy your own ticket in your currency in bring your physical ticket and airline receipt to reimburse from the Department of Health, Thailand. The reimbursement will be provided in cash (Thai baht)

#### **5. Visa Requirements**

Participants from ASEAN Member States who travel to Thailand for business and tourism purpose are allowed to enter the Thailand without visas for a stay not exceeding 30 days.

#### **6. Dress Costume**

- The recommended attire for the workshop is Business Attire.
- Participants are also encouraged to wear their national costumes during the welcome dinner on 6 March 2019.
- Smart casual is recommended during the study Tour visit on 7 March 2019.

#### **7. General Information**

- Time Zone: Bangkok, Thailand is in GMT+7 areas.
- Weather: The day time temperatures regularly average 33°C / 91.4°F or more, staying well above 25°C / 77°F at night.
- Electricity: The electric current in Thailand is 220/230 volts. Usually, plugs in Thailand are 2-pin round and 3-pin round/square and they accommodate both flat prongs (like in the U.S. and Japan) and round prongs (like most countries in Asia).
- Currency: The currency of Thailand is Thai Baht (THB). The current exchange rate for US\$ 1.00 is approximately 32.00 THB. International travellers can change their money at numerous exchange booths available at the airport. Most International credit cards such as American Express, Diners, Master and Visa are widely accepted. International ATM cards can also be used to withdraw the local currency from ATM machines. Ensure you inform your bank before travelling abroad, and be aware you may be charged for cash withdrawals.
